



## Angeline DiPietro Richter

February 8, 1917 - December 22, 2008

Angeline Kathleen DiPietro Richter, 91, of Kensington, widow of George A. Richter, passed away Monday December 22, 2008 at the Hospital of Central CT in New Britain. Born in New Britain on Feb. 8, 1917 to Vincenzo DiPietro and Carolina Lucco DiPietro, she attended New Britain public and parochial schools. An athletic child, she grew to be a graceful figure skater, a strong swimmer, and later became adept at archery and bowling. During World War II, she was employed at the Stanley Works, where she also volunteered as a reporter for The Stanley World, writing inspirational poems and articles and keeping up the newspaper's correspondence with Stanley employees in the service.

After the war, she moved to Kensington. For many years, she was a parishioner of Kensington Congregational Church, where she and her husband were active in the Mr. & Mrs. Club. In recent years, she joined St. Paul's Church in Kensington. For most of her life, she was a songwriter and several of her recordings were published in the late 50's and early 1960's. In her later years, her abiding belief in God inspired her to write many songs of faith. At the time of her death, she had dozens of songs under copyright.

Surviving are two sons, William Richter of Berkeley, CA and Glenn Richter of Kensington; a daughter, Kathleen Misterka and her husband Frederick of Kensington; two grandchildren, Kristina Carlson and Michael Misterka, both of

Kensington; several nieces, nephews, grandnieces and grandnephews. Besides her husband George, she was predeceased by two brothers, Angelo DiPietro and Samuel DePietro; and two sisters, Sebastiana "Anita" Pons and Josephine Warner. Whether we knew her as Mom or Grandma, Auntie Angie or Aunt Kathleen, "we will miss her".

Funeral service are Saturday 9 AM at Carlson Funeral Home, 45 Franklin Square New Britain, followed by a Mass of Christian Burial, 10 AM at St. Paul's Church, 479 Alling St., Kensington, CT 06037.
