



## Mark Giuliatti

November 29, 1949 - December 11, 2025

Mark A. Giuliatti, 76, of New Britain, husband of Stephen Hard, passed away Thursday, December 11, 2025, at their home. Born in New Britain, son of the late Alpio and Lena (Agostinucci) Giuliatti, he was raised in Newington before moving back to New Britain in 1980. Mark was a graduate of Newington High School, Class of 1967. Mark served with the US Air Force at Pope Air Field in North Carolina obtaining a BA from Campbell University while there. He worked with the Connecticut Department of Consumer Protection for 37 years, most notably administering its New Car Lemon Law. He retired in 2008. He was a parishioner at St. Mark's Episcopal Church in New Britain where he served on the Vestry and helped operate the Food Pantry. He continued on Vestry as St. Mark's merged with St. James Church in Farmington. He was a member of the New Britain Chapter of the Sons & Daughters of Italy; was a longtime volunteer at the New Britain Museum of American Art; and was an active member of the Art League of New Britain. He served for many years on the Board of the Greater New Britain Arts Alliance and more recently was a Historic Preservation Commissioner for the City of New Britain. Mark was a valued member of the International Association of Lemon Law Administrators, continuing this involvement even in retirement.

Besides his husband, Stephen, Mark leaves a sister, Gail Maglio and her husband Greg of Kensington and Engelwood, FL, a niece Kate Maglio and her fiancé Clinton Hacker of Glastonbury, nephews Dan Maglio of Kensington and Andrew Hard and Matthew Hard of Terryville and others.

Funeral services are Saturday, December 20, 2025, 10 AM at St. James Episcopal Church, 3 Mountain Road, Farmington, CT 06032 with military honors to follow at the church. Burial will be at the convenience of the family. Calling hours are Friday, December 19, 2025, 4 to 7 PM at the FAMILY HOME, 166 Lincoln Street, New Britain. “ Mark Giuliette: a true gem.

*I first met Mark sometime in the late 70s. He was working at the Dept of Health and I was at the Dept of Consumer Protection doing product safety work. Urea Formaldehyde Foam Insulation (UFFI) was a new product causing respiratory problems for some. Consumer Protection needed the instrumentation and expertise of the health dept to document conditions. Enter Mark; sling psychrometer in hand. Mark would walk through the rooms swinging this 3 ft baton at the end of a rope around his head like a lasso to get temperature and humidity. The man was inquisitive, confident, and easy to work with. Of course we had to get him from the soulless grasp of the DPH. 🙄*

*He entered Consumer Protection, (late 70s?) as a Product Safety Inspector. Product Safety is not for those looking for routine. Mark was tireless and creative in his quest for answers. A consumer complains that a spray caulk caused a rash. Next thing I see, Mark has sprayed the chalk on his wrist and covered it with a bandage to see if he would react. Or, a consumer complains about the safety of a “Chinese fighting star” sold with the toys. Mark brings a sample back to the office. Instructions say to throw it - he throws it - at the wall. Thunk. Like big thunk. Chinese fighting star is embedded ½ inch deep in the wall. Mark and I look wide-eyed at each other. Yeah, not a toy. Can’t remember what we told Public Works about the hole in the wall but Mark did inform the retailer that it must be displayed with sporting goods. And then there’s the time Mark and I are climbing on the roof of the State Office Building trying to get the broadcast signal from Greenwich mean time broadcast so we can test pacifiers. Climbing on the roof? Who does that? Mark was a passionate advocate for the consumer.*

*Ah, but then, as so often happens with those that are invaluable, he’s needed to step into a new program and align statute and processes. Product Safety may have lost an Inspector but the new car lemon law – first in the nation – had gained an advocate and*

*shepherd. Mark was quiet confidence. There were the legal challenges in the early days and detailed reporting requirements to track and submit – Mark was there, monitoring and adjusting. The Connecticut New Car Lemon Law has a sterling reputation. Mark's steady hand is written in the foundation for all to see.*

*I will miss you, my friend. I will miss the way you brought people together. I will miss the way you embraced challenges. I will miss the wide perspective you brought to situations. I will miss your gatherings. I will be your recipes. You are an angel my friend, of course you walk with them.*

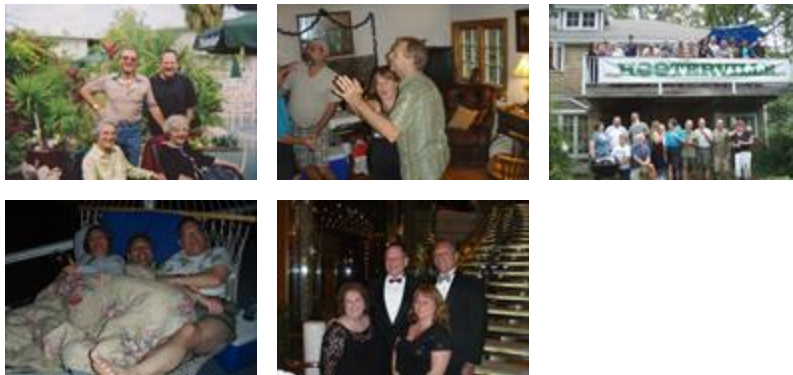
